# **SPECIAL TOWN MEETING (FY12) MAY 7, 2012**

The Special Town Meeting was called to order at 7:57 p.m. There were 227 voters checked off on the voting list, constituting the quorum requirement of 150 voters.

Acting Town Clerk, Dawn M. Varley read the warrant and the meeting voted as follows:

#### Article 1

The Town voted **UNANIMOUSLY** to transfer the sum of \$46,384.00 from the budget lines of the Fiscal 2012 budget as voted in the May 2, 2011 Annual Town Meeting to the budget lines as noted below, or take any other action relative thereto:

The Town voted **UNANIMOUSLY** to transfer the sum of \$147,763.69 from Water Enterprise Retained Earnings to pay a prior year bill to the City of Brockton for the purchase of water.

#### Article 3

The Town voted BY **STANDING VOTE, YES – 166, NO -52** to accept G.L. c. 64L, § 2(a) to impose a local meals excise.

#### Article 4

The Town voted **UNANIMOUSLY** to transfer the sum of \$60,000.00 from the Reserve for Appropriation Ambulance Fund (Ambulance Receipts) to the following budget lines of Article 2 of the May 2, 2011 Annual Town Meeting, or take any other action relative thereto.

All Other Services \$40,000.00 Expense 20,000.00

#### Article 6

The Town voted **UNANIMOUSLY** to transfer the sum of \$2,100.00 from Budget Line 95 – Expense, of the May 2, 2011 Annual Town Meeting for the purpose of purchasing chairs for the Whitman Senior Center, or take any other action relative thereto.

## Article 7

The Town voted **UNANIMOUSLY** to appropriate the sum of \$65,700.00 from free cash to fund a revenue shortfall and bring the Fiscal Year 2012 revenues and expenditures in balance, or take any other action relative thereto.

# **Article 8**

The Town voted **BY STANDING VOTE YES-227, NO** - **6** to appropriate the sum of \$8,000,000.00 to pay costs of designing, constructing, originally equipping and furnishing a new Department of Public Works Facility, including the payment of all costs incidental and related thereto; that to meet this appropriation the Treasurer, with the approval of the Selectmen, is authorized to borrow said amount under and pursuant to Chapter 44, Section 7(3) of the General Laws, or pursuant to any other enabling authority, and to issue bonds or notes of the Town therefor; provided, however, that no sums shall be borrowed or expended hereunder unless and until the Town shall have voted to exclude the amounts needed to repay any borrowing pursuant to this vote from the limitations on total property taxes imposed by Chapter 59, Section 21C of the General Laws (also known as Proposition 2 ½) or take any action relative thereto.

## Article 9

The Town voted BY **STANDING VOTE, YES – 218, NO -13** to transfer the Sum of \$500,000.00 from the Town Stabilization Account, the sum of \$300,000.00 from Sewer Enterprise Free Cash and the sum of \$200,000.00 from Water Enterprise Free Cash, for the purpose of supplementing the appropriation in the aforementioned Article 8 to pay costs of designing, constructing, originally equipping and furnishing a new Department of Public Works Facility, including the payment of all costs incidental and related thereto; and further that this appropriation is contingent upon voter approval of the debt exclusion referenced in said Article 8, or take any other action relative thereto.
